TO RESPOND TO FIRST AMENDED COMPLAINT**



On May 21, 2018, the District Court remanded the action to this Court on stipulation of the parties.


The parties agree that Defendants will answer or otherwise respond to the First Amended Complaint on or before Friday, June 8, 2018.
