

2 and control to Plaintiff is completed, the substantive content currently contained on those
3 websites and blogs is to be unpublished by the Plaintiff; (3) the Plaintiff shall not publish any
4 statements about Defendant Michal Osborn on the website abuseoflaw.org; (4) Defendants, and
5 all those acting in concert shall be ordered to remove and not to repost, copy, restate, duplicate,
6 or republish the content, comments or allegations regarding the Plaintiff, including but not
7 limited to republishing the content that was contained on the websites and associated blogs of
8 victimsofgeorgessharp.com and abuseoflaw.org on any other sites or blogs; and (5) if any other
9 website or blogs have already been established by the Defendants those websites and blogs shall
10 be unpublished forthwith.
