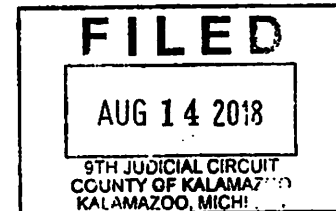


**ORDER TO AMEND SCHEDULING ORDER**

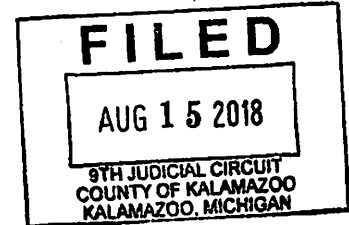
